On the advice of our attorney, we now have a NEW MAILING ADDRESS for the association. That new address is at the first of this newsletter under the heading HOA FEES.

**FINANCIAL REPORT** - Bill Wright, former Treasurer, reported there is currently \$22,931 in the checking account. A \$5,000 CD is still earning a small amount of interest at CNL Bank. The reserves are still below the recommended amount that the board agreed they should be. At this time there are no projects so the reserves will gradually be built up.
